

Respected Sir,

Sub: Requirements of the proposed mobile dental van.

As per your direction we visited Oxford Dental College and saw their Mobile dental van which has been designed by Mr. Naveen Rodrigues. It was as per the requirements of the Dental Council of India.

However our school/community oral health program caters to a minimum of around 20,000 individuals (adults and children) per annum averaging up to 250 being screened and treated daily. The areas covered are mostly in rural and semi urban areas around Bangalore city with a few outstation camps including Hosur and Tirunelvell areas. Therefore, we request that a few specific details to be considered for design of the proposed mobile dental van.

- 1. The vehicle should be air conditioned and of standard length (approximately 10 meters) width (2 1/2 meters) and minimum height to enable axis to rural areas. However, the windows should have movable
- 2. It should have two dental chairs (one fixed and the other chair may be portable, if storage space is
- 3. The van should have 12 seats to transport the dental team to and from the venue of the oral health
- 4. This seating area should also be designed as a health education area with an LED TV for health education.
- 5. Carrier on top to carry the team luggage when travelling for outstation camps.
- 6. The van should have two compressors). (This will provide a backup pressure source if one of the compressors should fail), with requisite air/water lines and plug in points (around 6) on the sides of the van. This is to enable setting up of multiple workstations around the van and allow screening and treatment to be done simultaneously without the space restriction in addition to the fixed units within
- 7. Interstate permit for a dedicated mobile clinic to allow the van to travel outside city limits.
- 8. Increased storage space within/outside the van to store and transport mobile dental units (Aseptico kits)

These modifications will enable us to maximize the utility of the mobile dental van to suit our pattern of working. These requirements are specific and in addition to the general requirements of a mobile dental van.


