
The Physical & Infrastructure Committee Meeting was held on 02.07.2020 at 2PM – 3PM in the Board Room.



- A detailed discussion was held on the issue of request for rubber mats by the department of conservative dentistry. The committee discussed the different options available in selection of rubber mats and also dealt in detail, the advantages and limitations of each of the options available. 


