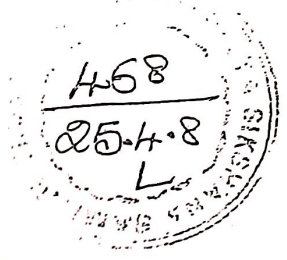
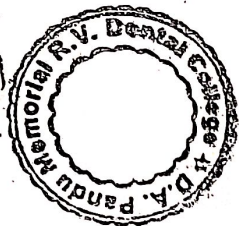

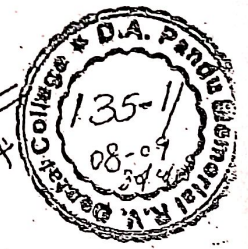

GUIDELINES FOR PROVIDING FINANCIAL ASSISTANCE
TO FACULTY MEMBERS OF COLLEGE FOR ATTENDING
INTERNATIONAL/NATIONAL CONFERENCE

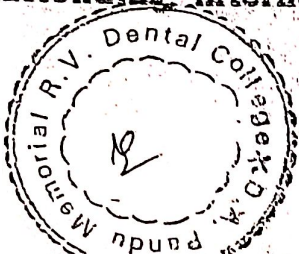
1. To encourage faculty of college who are engaged in research and are invited to present paper based on the results of their research in International Scientific Conference/National Conference.
2. The faculty member is eligible for financial assistance provided the conference/workshop/seminar is organized by recognized National International association of the concerned speciality. Those hosted by Commercial organizations will not be eligible for financial assist
3. Faculty having post graduate qualification only viz., MDSMS/MD/ F.D/ M.Sc. are eligible to participate in International/National Conference.
4. Faculty seeking financial assistance are required to furnish details to head of institution with enclosures as documentary proof, at least 3 months before the conference.
5. The Faculty should have been appointed against a permanent post in the college and should have worked atleast for a minimum period of 5 years in the case for International conference and 3 years in the case for National conference.
6. The Faculty seeking financial assistance should be the first author only, and is to be prepared on the results of original research carried out by him/her in the college in which he/she is appointed. In other words only the first author will be eligible for financial assistance.

7. The paper should have been accepted by the organizers of the overseas/National conference for presentation. Copy of acceptance letter should be enclosed.
8. Paper accepted for "Poster presentation" or case reports will not be considered for financial assistance.
9. Details of anticipated expenditure for travel, registration and other incidentals should be furnished. If the organizers have waived the Registration fee, partly or fully or offered any assistance for stay and travel, it should be mentioned clearly.
10. Extent of funding by other funding bodies, if any or proposed to be met from his/her own sources, should be indicated.
11. Financial assistance for an individual presenting a paper in an International/ National Conference will be given by rotation amongst eligible faculty in the department. However, if no other faculty is available than the faculty who has already availed the assistance will be eligible only once in two years.
12. The faculty has to hand over hard copy/C.D/ in respect of paper presented in the conference and also a copy of the proceedings of the conference should be given to the College Library.
13. The Financial Assistance (inclusive of Air fare/Registration) for attending international conference shall be as under.

a) CATEGORY I Maximum Rs. 50,000

- i. Western countries including Japan, South Korea and China.
- ii. All European Countries viz. U.K. France, Germany, Belgium, Italy, Spain, Norway, Poland, USSR, Switzerland, Hungary, Romania, Turkey, Moscow, Yugoslavia etc.,
- iii. Pacific countries like Australia, New Zealand, Fiji, Tonga, Neuru etc.
- iv. African countries like Algeria, Egypt, Ghana, South Africa, Sudan, Zaire, Zimbabwe etc.,
- v. U.S.A. Canada, Brazil, Argentina and other North & South American Countries.

b) CATEGORY II Maximum Rs. 30,000

Eastern Countries like Hongkong, Indonesia, Malaysia, Kuwait, Dubai, U.A.E. Oman/Qatar, Singapore, Thailand, Saudi Arabia, Afghanistan, Bahrain, Myanmar (Burma) Mauritius, Phillipines, etc.,

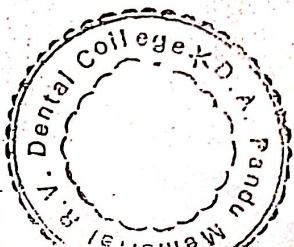
c) CATEGORY III Maximum Rs. 15,000

SAARC Countries viz., Pakistan, Sri Lanka, Nepal, Bhutan, Maldives and Bangladesh.

14. The financial assistance (inclusive of Air fare/Registration) for attending National Conference shall be Rs. 15,000 (Maximum).

15. The Head of the Institution may in exceptional cases consider/ recommended for higher financial assistance.

16. The absence during conference/Travel shall be treated as special Casual leave.
